“Monster Cash” Slot Tournament

PROMOTION ELIGIBILITY

- 1.** This promotion is sponsored by the REDSHORES Racetrack & Casino and is open to any participant who is nineteen (19) years of age or older, except employees of Atlantic Lottery (AL), AL’s advertising agencies, or any immediate family of the above. “Immediate Family” means the spouse, sibling, parent and/or child of an employee referred to above who resides with that employee. Red Shores’ employees and their immediate family are not permitted to participate in this promotion. Any person who has self-excluded, trespassed or for any reason is restricted from RED SHORES is not eligible to participate in the tournament.
- 2.** In the event a selected contestant does not meet the eligibility requirements, then RED SHORES has no obligation to award any prize to that selected contestant.
- 3.** Winners must present valid photo identification acceptable to RED SHORES and sign, before receiving the prize, a declaration and release, as well as answer a mathematical skill testing question. All answers are final, and if incorrect, the selected contestant will not receive the prize.

KEY TERMS

Session – 1 minute of play at a tournament machine against other participants for points.

Round – One or multiple sessions grouped together in a time period, competing against each. 4 Rounds total in tournament; 2 Qualifying Rounds, 1 Semi-Final Round, and 1 Final Round.

HOW TO ENTER

4. Slot Tournament Registration

Any Red Shores guest who meets the eligibility requirements is permitted to participate in the Monster Cash Slot Tournament. Registration opens Friday, October 1st at 11am until all sessions are filled, on or before the tournament date. Maximum of 50 participants permitted. To register for the tournament, guests must visit the Rewards Desk or call 902-620-4266. Tournament buy in is \$50 or 5000 Rewards Club points. Tournament buy-in includes: 2 guaranteed sessions, \$10 in RS Free Play, and an Eerie Eats meal voucher for Red’s Gold Cup Lounge. Participants will receive their buy-in package on October 30th – check-in begins at 5pm and the tournament begins at 6pm.

4.1 The total buy-in amount of \$50 goes entirely to the prize pool (\$50 x 50 players = \$2,500 prize pool). The prize pool of \$2,500 is guaranteed by Red Shores, and will be paid out regardless of the tournament selling out. The complimentary RS Free Play and Eerie Eats meal voucher is not included in the value of the buy-in, and are provided in addition to players at the expense of Red Shores. The Eerie Eats meal voucher is valid on the date of the Monster Cash Slot Tournament only. No cash value.

4.2 The maximum number of participants for this slot tournament is 50. Participants may only register once for the tournament. In the eventuality that there are no more scheduled sessions or available seats, the player will not be registered and no compensation will be provided.

4.3 In the instance that the tournament must be cancelled, registered participants will be contacted as soon as possible, and refunded their total buy-in amount of \$50. There will be no compensation made in addition to the refunded buy-in, the meal voucher and RS Free Play will not be provided.

4.4 Tournament seats are transferrable. If a registered participant is unable to attend the tournament, or miss their session of play, they will not be reimbursed for their buy-in amount but are permitted to transfer their entry to another player.

5. Slot Tournament Check-In

The day of the tournament, all players who are registered for the tournament must check-in at the tournament registration desk located in the main lobby Saturday, October 30th beginning at 5:00 PM.

5.1 Each guest who enters the tournament will receive a card at check-in. The card will have two sides:

1. **Time Session Card:** with the participant’s name, session time, and date. This card must be presented to the tournament host before the start of their designated session time.
2. **Ballot Card:** will include the participant’s name and phone number. Prior to the Semi-Final Round, players who did not qualify during their first two Rounds, will have a chance to re-enter via a second chance draw.

TOURNAMENT FORMAT

6. Session Play Times – 1 Minute Tournament Play + 2 Minutes Admin Time.

It is the duty of the registered participant to be ready to play at their session time. If a participant misses their scheduled session time, they will forfeit and will not be provided another time in that Round. No compensation will be provided for missed sessions.

7. Qualifying Rounds

There are two Qualifying Rounds held for this tournament. Each Qualifying Round will consist of 16 Sessions, with 3 participants per Session, and 1 Session with 2 participants, for a total of 50 participants. All registered participant will play one Session, in each Qualifying Round, for a total guarantee of two sessions during the tournament. The top 12 scores, based off of each participant’s combined scores from both Round 1 and 2 sessions, will move onto the Semi-Final Round (Third Round).

7.1 If sessions are partially filled they may still take place, based upon the Tournament Host’s discretion.** All decisions of the Tournament Host & Gaming Supervisors with respect to this promotion are final.

**Start times of the sessions are approximate and may need to be adjusted due to unforeseen circumstances.*

***Number of players in each session may vary depending how many register for the October 2021 Slot Tournament.*

8. Second Chance Draws

Participants, who did not qualify within the top 12 scores of Rounds 1 & 2, will have a second chance to move onto the Semi-Final Round. Three (3), second chance ballots, will be drawn from the total pool of entry cards. These three (3) participants, if present at the time of the draw, will participate in the Semi-Final Round with the top 12, for a total of 15 participants.

8.1 It is the duty of all participants that wish to take-part in the second chance draws to be present if their name is called to play. If they are not present the seat will go unclaimed and they will forfeit any chance to play later sessions, and there will be no compensation provided.

9. Semi Final Round

The Semi-Final Round will consist of a maximum of 15 participants. Each participant will play once, in one of the 5 Sessions. The 3 highest scores from all of the 15 players will move onto the Final Round.

10. Final Round

The Final Session will be one (1) Round of 3 participants, who will be playing for cash prizing. If participants who qualified for the Final Round do not show up for the Finals session time, they will forfeit their seat and it will not be filled. The 3 finalists will all receive a prize based on their score from the Final session.

Prizing

11. Final Round – The 3 Finalists, determined by the 3 highest scores from the Semi-Final Round, will play in the Final Session. All 3 Finalists will receive a cash prize depending on the finishing order of points they receive in the Final Session of play. The applicable prizes are listed in the timetable above.

WINNER ELIGIBILITY

12. No substitute prizes will be awarded in the event that prizes are not claimed.
