## **RED SHORES at Summerside and Charlottetown**

## **PROMOTION ELIGIBILITY:**

- This promotion is sponsored by Red Shores and the PEI Standardbred Horse Owners Association (PEISHOA) and is open to any participant, who is nineteen (19) years of age or older, except employees of RED SHORES, Atlantic Lottery (AL), or any immediate family of the above. "Immediate Family" means the spouse, sibling, parent and/or child of an employee referred to above who resides with that employee.
- 2. In the event a selected contestant does not meet the eligibility requirements, then RED SHORES and/or the PEISHOA has no obligation to award any prize to that selected contestant.

#### HOW TO ENTER:

- 3. **Simulcast Racing** To enter contestant's must pay \$20 each day to receive their entry form. Contestants must be present in order to receive and submit their entry form. No person shall directly or indirectly act as an intermediary, transmitter, or agent in submitting an entry form on any contenstant's behalf.

- 6. In the event of a track cancellation, contestants will have other 2 tracks to pick from.
- 7. In the event of a site closure at Red Shores Summerside or Charlottetown locations, the competition will be cancelled for that day and carried over to the following Friday.

#### 7.1. The same rules and regulations apply on the carry-over day.

8. Entry Fee – The \$20 entry fee is **non-refundable** and required with each entry form; cash is the only method of payment accepted.

#### WAGERING FORMAT:

- 9. Each contestant will have a \$50 fantasy bankroll per day to bet one or all three (3) of the tracks offered. The contestant can choose from the following pools: Win or Place.
  - **9.1.1.** Minimum \$2 and Maximum \$10 can be bet on pool/track of your choice.
- 10. Minimum of three (3) different races must be wagered to be eligible for contest.
- 11. Earning cap of \$300 per day will be in effect
- 12. The best 6 out of 7 weeks will be used to calucuate the overall winner.
- 13. The contestant with the highest dollar total following contest completion will be the overall winner. Announcement to be made on Saturday, May 14<sup>th</sup>, 2022 during Live Race Broadcast.

**13.1.1.** Winner will need to provide prize choice no later than noon on Friday, May 20<sup>th</sup>, 2022.

14. In the event that two (2) or more contestants have the same bankroll upon completion of the contest, the actual total winning tickets will be used as a tie breaker.

**14.1.1.** Any decisions of RED SHORES and/or PEISHOA in all matters or disputed relating to this handicapping challenge are final.

- 15. Weekly Winners Each Saturday the prizing will be a \$25 racing voucher awarded to the highest weekly winner.
- 16. Grand Prize Winner prizing will consist of one (1) of the following options:
