

## **OFFICIAL RULES AND REGULATIONS**

### **PROMOTION ELIGIBILITY**

1. This promotion is sponsored by Red Shores Racetrack & Casino and is open to any Red Shores simulcast guest who is nineteen (19) years of age or older, with the following exceptions: Current or former employees of Atlantic Lottery (including Red Shores Racetrack & Casino), or of any promotional agency involved with this promotion, and any Immediate Family members of any of these employees, which employees and their Immediate Family members shall be ineligible to participate in and/or claim any reimbursable prize for this contest.
  - 1.1 "Immediate Family" means the spouse, sibling, parent and/or child of an employee referred to above who resides with that employee.

### **HOW TO ENTER**

2. To enter FASTBET players wagering \$60 or more on any available Simulcast track on any of the specified Mondays (March 13, 20 & 27) will receive a \$20 credit to their FASTBET player accounts on the next business day when the United Tote wager verification report is complete.
3. To enter Cash wagering guests (Non-FASTBET card holders) must purchase ten (10) \$2 WIN tickets in the first four races of any available Simulcast track on any of the specified Mondays (March 6, 13, 20 & 27). Guest with at least five (5) winning tickets will receive a Red Shores \$20 Racing Voucher following verification of winning tickets.
4. All cash wagered tickets will be branded with a stamp at time of purchase and CANNOT be canceled. Branded tickets must be presented for verification to claim the Red Shores \$20 Race Voucher.
5. Promotion resets each Monday as listed above.

### **HOW TO REDEEM**

6. The \$20 FASTBET account credit will automatically be added to eligible accounts on the following business day.
7. Red Shores \$20 Racing Voucher will be issued following verification of branded winning tickets on the days of contest.
