### Simulcast promotion occurring Friday's starting April 5<sup>th</sup>, 2024 through May 10<sup>th</sup>, 2024

#### **RED SHORES Charlottetown & Summerside Locations**

#### **PROMOTION ELIGIBILITY:**

- 1. This promotion is sponsored by Red Shores. It's open to any Red Shores guest who is nineteen (19) years of age or older, except employees of RED SHORES, Atlantic Lottery (AL), or any immediate family of the above.
  - 1.1 "Immediate Family" means the spouse, sibling, parent and/or child of an employee referred to above who resides with that employee.
- 2. In the event a selected contestant does not meet the eligibility requirements, then RED SHORES has no obligation to award any prize to that selected contestant.

#### HOW TO ENTER:

- 3. Players Sweepstakes Handicapping Challenge takes place on the following Friday's, April 5<sup>th</sup>, 12<sup>th</sup>, 19<sup>th</sup>, 26<sup>th</sup>, May 3<sup>rd</sup> and 10<sup>th</sup> 2024 at both Red Shores location in Charlottetown and Summerside.
- 4. Participants are required to submit entry fees & forms to the designated Red Shores employee (herein "Contest Organizer") prior to the first race post time.
- 5. Contestants must pay \$20 entry fee each contest day to receive their entry form. Contestants must be present to receive and submit their entry form. No person shall directly or indirectly act as an intermediary, transmitter, or agent in submitting an entry form on any contestant's behalf.

5.1 - Entry Fee – The \$20 entry fee is **non-refundable** and required with each entry form; cash is the only method of payment accepted.

- 6. One entry per contestant per day. Contestants must have their selections documented on the entry form and turned in to contest organizers on the day of, no later than the first selected track(s) post time. Selected tracks will be listed on the entry form.
- 7. Once Submitted no changes will be permitted. In the event of a late scratch, contestant will be awarded the post time favorite or the second favorite if first is scratched and so on.
- 8. In the event of a track cancellation, contestants will have two other tracks to choose from.
- 9. In the event of a site closure at Red Shores Summerside or Charlottetown locations, the competition will be cancelled for that day and carried over to the following Friday, thus extending the contest end date.
- 10. The same rules and regulations apply on the carry-over day.
- 10 Results will be calculated the following day based on how their selection finished in the official Race Results & Prices.

### WAGERING FORMAT:

- 11 Each contestant will have a \$50 fantasy bankroll per contest day to bet one (1) or all three (3) of the tracks offered. The contestant can choose from the following pools: Win or Place.
  - 11.1 Minimum \$2 and Maximum \$10 can be bet on pool/track of your choice.
- 12 Minimum of three (3) different races must be wagered to be eligible for contest.
- 13 Earning cap of \$300 per day will be in effect.
- 14 The best 5 out of 6 weeks will be used to calculate the overall winner.

- 15 The top three contestants with the highest dollar total in their fantasy bankroll following contest completion will be granted the 1<sup>st</sup>, 2<sup>nd</sup> & 3<sup>rd</sup> prize in accordance with their placement. Announcement to be made during the next Live Race Broadcast.
- 16 In the event that two (2) or more contestants have the same bankroll upon completion of the contest, the actual total number of winning tickets will be used as a tie breaker. In the event this does not break the tie, the contestants' names will be placed in a draw for the respective placing and corresponding prize.
- 17 Any decisions of AL/ RED SHORES in all matters or disputes relating to this contest are final.

# WINNER ELIGIBILITY:
