**Conditions:**

1. All events conducted under the rules and regulations of the Atlantic Provinces Harness Racing Commission, Standardbred Canada, hosted at Red Shores at Summerside Raceway and Red Shores at the Charlottetown Driving Park.
2. Declarations close at the time and date posted on the weekly condition sheet.
3. All races will be at a distance of one (1) mile unless otherwise stated.
4. All starting positions shall be drawn electronically using the electronic draw system provided by Standardbred Canada.
5. Purse distribution:
  - a) 5 or more starters: 50 — 25 — 12 — 8 — 5%;
  - b) 4 starters: 50 — 25 — 15 — 10%;
  - c) 3 starters: 60 — 30 — 10%;
  - d) 2 starters: 65 — 35%;
  - e) 1 starter: 100%.
6. The top eight (8) Money Earners from the above events will be invited to the Island Ocean Trot Final.
7. In the event any of the top Money Earners are unable to participate in the Final, the next highest money earner will be invited to the Island Ocean Trot Final.
8. In the event of a tie, the entry will be selected by lot.
9. Competing horses must be owned at time of nomination and declaration by a resident of the Atlantic Provinces and maintain ownership by a resident of the Atlantic Provinces while racing in the series.
10. If leased, both lessee and lessor must be residents of the Atlantic Provinces at time of nomination, declaration and competition in each component of the series.
11. The winning Owner in the Island Ocean Trot Final will be presented an award by Burkie By The Bay Stable.
12. All owners, trainers, drivers must be members in good standing with the APHRC and Standardbred Canada.
13. All horses must meet the qualifying standards of Red Shores.
14. In the consolation or final, should there be horses with common ownership; Host tracks reserves the right to uncouple horses for pari-mutuel purposes as per APHRC Rule 206.
15. A declaration for this event is an agreement to all the above terms and conditions.
