OFFICIAL RULES AND REGULATIONS

PROMOTION ELIGIBILITY

- 1. This promotion is sponsored by Red Shores Racetrack & Casino. This promotion is open to any Red Shores guest who is nineteen (19) years of age or older, with the following exceptions: Current or former employees of Atlantic Lottery Corporation (including Red Shores Racetrack & Casino), or of any promotional agency involved with this promotion, and any Immediate Family members of any of these employees, which employees and their Immediate Family members shall be ineligible to participate in and/or claim any reimbursable prize for this contest.
 - 1.1 "Immediate Family" means the spouse, sibling, parent and/or child of an employee referred to above who resides with that employee.

HOW TO ENTER

- 5. The Pony Point Challenge takes place during live race events at Red Shores Charlottetown June 22nd, June 29th, July 6th, July 13th & July 27th 2024.
- 6. Contestants must purchase a minimum \$2-win, place or show ticket per race for the first 10 races at Red Shores Racetrack and Casino on selected dates. Tickets will be verified and stamped by the Race Lead. Tickets cannot be cancelled.
- 7. Entry forms must be submitted prior to the first race post time at Red Shores Racetrack and Casino. No changes are permitted once the form has been submitted. Entry form selections for the first 10 races must correspondence with the purchased tickets.
- 8. Points will be awarded based on how their selection finished in the Race Results.

8.1 Point breakdown:

Selected Horse Finishing Place	Points Awarded
1 st (Win)	5 Points
2 nd (Place)	3 Points
3 rd (Show)	1 Point

- **8.2 Bonus Points** Contestants can earn 5 bonus points if they select the Driver on their entry form with the most wins for the first 10 races.
- 9. Maximum of one entry per contestant, per event date, at each Red Shores location.
- 10. In the event of a late scratch, the contestant will be awarded the post time favorite.
- 11. In the event of a track cancellation, it will be announced by a Red Shores Racing Official, what, if any, new dates will be selected.
- 12. In the event of a site closure, the contest will be cancelled for that day.

PRIZING

13. The top three contestants with the most points at the end of the promotional period, will be awarded a prize. Prizing includes:

In the event this results in a tie still, the highest number of place selections will be the winner. If this does not break the tie, the prize will be split between both winners. The same guidelines will take place for 2nd and 3rd Place if there is a tie.
