

OFFICIAL RULES AND REGULATIONS

Winter Survivor Challenge

Dates: January 31st, February 7th, 14th, 21st, 28th

Red Shores Charlottetown & Summerside Locations

CONTEST ELIGIBILITY

1. This contest is sponsored by Red Shores. This contest is open to any Red Shores guest who is nineteen (19) years of age or older, with the following exceptions: Current employees of Atlantic Lottery Corporation (including Red Shores Racetrack & Casino), or of any contest agency involved with this contest, and any Immediate family members of any of these employees, which employees and their immediate family members shall be ineligible to participate in and/or claim any reimbursable prize for this contest.
 - 1.1 "Immediate Family" means the spouse, sibling, parent and/or child of an employee referred to above who resides with that employee.
2. Participants are required to submit entry forms, and tickets to the designated Red Shores employee (herein "Contest Organizer") prior to the first race post time.
3. In the event a participant does not meet the eligibility requirements, then Red Shores has no obligation to award any prize to that selected contestant.
4. Winners must present valid photo identification acceptable to Red Shores, that matches the names on their entry form and sign a declaration and release before receiving the prize.

HOW TO ENTER

5. The Winter Survivor Challenge takes place on the following Fridays, January 31st, February 7th, 14th, 21st, 28th at both Red Shores locations in Charlottetown and Summerside.
6. Contestants are required to purchase a Win/Place/Show ticket, with a minimum wager amount of \$2 (total ticket cost is \$6) for each of the four (4) selected races at **Meadowlands Racetrack** (total minimum purchase \$24).
7. Contestants will receive their entry form from the Contest Organizer. Contestants will complete their entry form on each race date listed above they choose to participate.
 - 7.1 **Entry forms and tickets must be verified by the Contest Organizer, Racing Lead, prior to the first race post time. No changes are permitted once the form has been submitted.**
8. On their entry form, contestants must select a horse to win/place/show (W-P-S) for each of the four (4) designated races on the specified dates at Meadowlands Racetrack.
9. Results will be calculated and posted the following day based on how contestants' selections finish using the United Tote official Race Results & Prices.
10. Contestants must "survive" by finishing in-the-money (i.e. one "win, place, or show wager must be a winning wager) with at least one (1) of their four (4) selections, each day of the challenge. Failing to do so, or not making any selections for a contest day will prevent the player from advancing in the game.
 - 10.1 To aid in the player's survival, one "**horseshoe**" is provided to each contestant. The horseshoe is a onetime "free pass". It allows the contestant to "**survive**" if they do not submit an entry form for a race card **or** all four (4) of their selections fail to hit the board.
 - 10.2 If the contestant has used their "**horseshoe**" and the challenge is not finished, their total winnings will plateau, and no further play will be permitted for the remainder of the challenge. Contestants winning results will carry forward in the weekly scoreboard; if the challenge ends with them in the top three, they will win the corresponding prize.
 - 10.3 If the player completes the Winter Survivor Challenge without redeeming their "horseshoe," they will be awarded a \$15 wagering voucher.
11. Maximum one entry per contestant, per event date, at either Red Shores location. (i.e. you can only play at one (1) Red Shores location on any given day during the contest period)
12. In the event of a late scratch (horse is removed from race prior to race start), the contestant will be awarded the post time favorite (the horse considered most likely to win based on the odds at post time).

13. In the event of a race or track cancellation, it will be announced by a Red Shores Racing Lead, what, if any, new race or track will be selected to replace it on the current contest day.
14. In the event of a “no contest” race, where no results are available, there will be no pays or winnings assigned for these races.
15. In the event of a site closure (Red Shores), the contest will be cancelled that day with no makeup date added.

PRIZING

16. The top three contestants with the highest winnings at the end of the contest period, will be awarded accordingly.

1 st Place	\$500 Cash
2 nd Place	\$100 FastBet card & \$25 Red Shores Gift Card & Red Shores Swag Bag
3 rd Place	\$50 FastBet card & Red Shores Swag Bag

17. In the event of a tie at the end of the challenge, the contestant with the highest number of win selections will be identified as the winner. In the event this results in a tie still, the highest number of place selections will be the winner. If this does not break the tie, the prize will be split between the winners. The same guidelines will take place for 2nd and 3rd place if there is a tie.

WINNER ELIGIBILITY

18. Potential winners do not need to be present to claim the prize at the time of the announcement. The winner will be contacted by the Contest Organizer to arrange prize pick- up at Red Shores Charlottetown or Summerside.
19. The prize is non-transferable. All prizes are awarded as is and cannot be substituted or exchanged.
20. Winners must present valid photo identification acceptable to Red Shores, that matches the name on their entry form and sign a declaration and release before receiving the prize. For any cash prizes, the winner must answer a mathematical skill testing question. All answers are final, and if incorrect, the selected contestant will not receive the prize.
 - This signature will function as confirmation of contest eligibility and compliance with the contest rules.
21. Red Shores has no obligation to award any substitute prize and/or award any prize for any incorrect skill testing question or if they fail to meet the above contest requirements.
22. Contestants must be nineteen (19) years of age or older.

GENERAL RULES

23. By entering this contest, participants agree to release and hold harmless Atlantic Lottery Corporation, Red Shores Charlottetown and Summerside, (collectively the “Released Parties”), and the shareholders, directors, officers, employees, and agents of the Released Parties from any claim, loss, expense, or other liability arising from participation in this contest or the awarding, acceptance or use of any prize awarded under the contest.
24. All matters and disputes relating to this contest will be reviewed and decided by Red Shores. Decisions of Red Shores with respect to this contest are final on all matters of fact, interpretations, eligibility and procedure.
25. No prize substitutions or equivalent cash payments will be made, except for Red Shores’ right, at its sole discretion, to make a prize substitution or cash payments of equivalent kind and value. Except as specifically provided here in, a prize, if unclaimed, will not be awarded.
26. Participation in this contest authorizes Red Shores the right to publish the claimant’s name, or photograph without any claim for broadcasting, printing, social media, or other rights. The claimant

shall have no claim against Red Shores for invasion of privacy, infringement of copyright or otherwise by reason of the publication or broadcasting of the Claimant's name, address and/or photograph.

27. Red Shores reserves the right to verify the full legal name of the claimant with the information on entry form. To claim the prize, government issued photo identification, acceptable to RED SHORES, is required.
28. All entries become the property of Red Shores who assumes no responsibility for garbled, illegible, lost, late, delayed, destroyed, or misdirected mail, voice messages, e-mail or any computer errors or malfunctions. No contest entries will be entered into except with entries selected as potential winners.
29. 30. Entry materials/data that have been tampered with or altered are void.

If for any reason, in the opinion of Red Shores, in its/their sole discretion, the contest is not capable of running as originally planned, or if the administration, security, fairness, integrity or the proper conduct of the contest is corrupted or adversely affected, including without limiting the generality of the foregoing, by reason of infection by computer virus, bugs, tampering, unauthorized intervention, legal or regulatory concerns, fraud, technical failures or any causes beyond its/their control, Red Shores reserves its/their right to cancel, terminate, modify, amend or suspend the contest including canceling any method of entry, and select a winner from previously received eligible entries.
32. Red Shores reserves their right to modify the official rules and regulations of this contest without materially affecting the terms and conditions hereof. Red Shores reserves their right in their sole discretion to disqualify any individual they find to be tampering with the entry process or the operation of the contest or to be acting in violation of these official rules and regulations or otherwise in a disruptive manner.
33. This contest is subject to all applicable federal, provincial, and municipal laws and regulations. By entering this contest, each entrant consents to the collection, use and distribution of his/her personal information (information that identifies an entrant as an individual, such as home telephone number, age, and home address) by Red Shores for the purposes of implementing, administering, and fulfilling this contest. Red Shores will not sell or transmit this information to third parties except for the purposes of administering this contest. Red Shores is committed to ensuring the privacy of its players and taking all the necessary precautions to ensure player information is safeguarded. In all cases, information is retained in secure facilities and protected from unauthorized access. Red Shores will only use or disclose player information for the specific purposes for which it was collected, unless required by law, and will only retain the information long enough to fulfill these purposes, after which time it will be securely destroyed.
34. Red Shores is not responsible for commencing, continuing, or completing the "Winter Survival Challenge" or awarding prizes in the event of circumstances beyond Red Shores' or AL's control, and Red Shores may, at its sole discretion, change or alter this contest, as Red Shores deems necessary.
35. All references to times and dates reflect Atlantic Standard Time.
36. These Official Rules and Regulations govern the contest and must be followed and by agreeing to participate in the contest, all contestants agree to comply with, and be bound by these Official Rules and Regulations.
