

# 2025 All Star Cresting Trot Series

For 3 YO Trotters, open to colts, geldings & fillies who are:

- 1) Maritime Foaled and/or
- 2) Maritime Sired and/or
- 3) PEI Owned as of **June 1, 2025**

No Starting Fee in any Leg

All horses competing in this event must meet the qualifying standards of Red Shores

Thursday, June 26th	CDP	\$7,000

**The top money earning filly from this series will receive a \$1,500 Bonus.**

Conditions:

1. All events conducted under the rules and regulations of the Atlantic Provinces Harness Racing Commission, Standardbred Canada and Red Shores.
2. Declarations close at the time and date posted on the weekly condition sheet.
3. All races will be at a distance of one (1) mile unless otherwise stated.
4. All starting positions shall be drawn electronically using the electronic draw system provided by Standardbred Canada.
5. Purse distribution:
  - a) 5 or more starters: 50 — 25 — 12 — 8 — 5%;
  - b) 4 starters: 50 — 25 — 15 — 10%;
  - c) 3 starters: 60 — 30 — 10%;
  - d) 2 starters: 65 — 35%;
  - e) 1 starter: 100%.
6. A minimum of six (6) entries are required to fill each leg.
7. A minimum of (5) entries of each sex is required in order to have a separate division for fillies and a separate division for colts/geldings in all legs. If the minimum number of entries per sex is not achieved in each leg, then colts/geldings/fillies will race together.
8. All colts/geldings/fillies are required to participate in both legs 1 and 2, to be eligible for leg 3. Horses will be classified by earnings in the series for leg 3.
9. If there is more than one division of the legs, each division will race for 100% of the advertised purse.
10. All owners, trainers, drivers must be members in good standing with the APHRC and Standardbred Canada.
11. **All horses must meet the qualifying standards of Red Shores.**
12. Should there be horses with common ownership; Host track reserve the right to uncouple horses for pari-mutuel purposes as per APHRC Rule 206.
13. A declaration for this event is an agreement to all the above terms and conditions.
14. Red Shores reserves the right to make any changes to conditions and schedule they deem necessary.
15. Red Shores accepts no responsibility or liability for any accident, loss, or damage, which may occur on their property as a result of these, or any races.
