Conditions:

1. All events conducted under the rules and regulations of the Atlantic Provinces Harness Racing Commission, Standardbred Canada and Red Shores.
2. Declarations close at the time and date posted on the weekly condition sheet.
3. All races will be at a distance of one (1) mile unless otherwise stated.
4. All starting positions shall be drawn electronically using the electronic draw system provided by Standardbred Canada.
5. Purse distribution:
 - a) 5 or more starters: 50 — 25 — 12 — 8 — 5%;
 - b) 4 starters: 50 — 25 — 15 — 10%;
 - c) 3 starters: 60 — 30 — 10%;
 - d) 2 starters: 65 — 35%;
 - e) 1 starter: 100%.
6. The top eight (8) Money Earners from the above events will be eligible to the Island Oceans Trot Final.
7. In the event any of the top Money Earners are unable to participate in the Final, the next highest money earner will be eligible to the Island Oceans Trot Final.
8. In the event of a tie, the entry will be selected by lot.
9. Competing horses must be owned at time of nomination and declaration by a resident of the Atlantic Provinces and maintain ownership by a resident of the Atlantic Provinces while racing in the series.
10. If leased, both lessee and lessor must be residents of the Atlantic Provinces at time of nomination, declaration and competition in each component of the series.
11. To be eligible for the final, an entry must have competed in at least two (2) legs of the series. The winning owner of the Island Oceans Trot Final will be presented an award by Burkie By The Bay Stable.
12. All owners, trainers, drivers must be members in good standing with the APHRC and Standardbred Canada.
13. Red Shores reserves the right to make any changes to conditions and schedule they deem necessary.
14. **All horses must meet the qualifying standards of Red Shores.**
15. In the consolation or final, should there be horses with common ownership; Host tracks reserve the right to uncouple horses for pari-mutuel purposes as per APHRC Rule 206.
16. A declaration for this event is an agreement to all the above terms and conditions.
17. Red Shores accepts no responsibility or liability for any accident, loss, or damage, which may occur on their property as a result of these, or any races.
