

OFFICIAL RULES AND REGULATIONS

Player Sweepstakes Handicapping Challenge

Simulcast Promotion Occurring on Fridays starting April 4th, 2025, through May 9th, 2025

RED SHORES Charlottetown & Summerside Locations

PROMOTION ELIGIBILITY:

1. This promotion is sponsored by Red Shores and is open to any participant, who is nineteen (19) years of age or older, except employees of RED SHORES, Atlantic Lottery (AL), or any immediate family of the above.
 - 1.1. **“Immediate Family” means the spouse, sibling, parent and/or child of an employee referred to above who resides with that employee.**
2. In the event a selected contestant does not meet the eligibility requirements, RED SHORES has no obligation to award any prize to that selected contestant.

HOW TO ENTER:

3. **Entry Fee.** A \$20 entry fee is required weekly to enter the Player Sweepstakes Handicapping Challenge.
 - 3.1. This fee is **non-refundable** and required with the entry form to be entered into the contest; cash is the only method of payment accepted
4. **To enter.** Contestants must be present in order to receive and submit their entry form. No person shall directly or indirectly act as an intermediary, transmitter, or agent in submitting an entry form on any contestant's behalf.
5. **One entry per contestant per day.** Contestants must have their selections documented on the entry form and turned into contest organizers by the day of the challenge, no later than the first selected track(s) post time.
6. **Once Submitted.** No changes will be permitted. In the event of a late scratch, contestant will be awarded the post time favorite.
7. In the event of a track cancellation or a no contest ruling, the contestants affected will be awarded a “fantasy refund” of the dollar amount used on the track that cancelled. The “fantasy refund” will be added to their “weekly earnings” on the effected day of the contest..
8. In the event of a site closure at Red Shores Summerside or Charlottetown locations, the competition will be cancelled for that day and the challenge will be extended a week to add in the missed day.
 - 8.1. The same rules and regulations apply on the carry-over day.

WAGERING FORMAT:

9. Each contestant will have a *\$50 fantasy bankroll per day of the Handicapping Challenge to use.*
10. Contestants **MUST wager** at a minimum of **two (2)** of the selected tracks offered.
 - 10.1. A minimum of **three (3)** different races must be wagered on.
 - 10.2. A **minimum \$2** and **Maximum \$10** wager amount is made on the selected pool/track of your choice.
 - 10.3. Pools offered in contest are, **Win** or **Place ONLY**
11. **Earning cap of \$300 per day** will be in effect.

12. **The best 5 out of 6 weeks** will be used to calculate the overall total dollar amount of the winner.
13. **The top three (3) contestants with the highest dollar total following contest completion will be deemed the winners.** Announcement to be made during the Live Race Broadcast on Saturday May 10th 2025.
14. In the event that two (2) or more contestants have the same total dollar amount upon completion of the contest, the total number of correct bets will be counted and used as the tie breaker.
 - 14.1. **Any decisions of AL, RED SHORES in all matters or disputes relating to this contest are final.**

PRIZING

15. **Weekly Winners** – Each Monday, a \$25 racing voucher/Fastbet deposit is awarded to the highest weekly winner.
16. **Final Top Three Winner**
 - 1ST PLACE - CASH PRIZE OF \$1500 (fifteen hundred dollars CDN)**
 - 2ND PLACE - CASH PRIZE OF \$750 (seven hundred fifty dollars CDN)**
 - 3RD PLACE - CASH PRIZE OF \$250 (two hundred fifty dollars CDN)**

WINNER ELIGIBILITY:

17. Potential winners do not need to be present in order to claim the win. Winners can collect their prize from the Racing Lead. **If a winner has not collected their prize within (2) two weeks of the “Players Sweepstakes Handicapping Challenge” ending, they will no longer be eligible to receive the prize. In that case, the prize will not be awarded.** No substitute prizes will be awarded in the event that prizes are not claimed.
18. In order to be declared a winner, a winner must present valid photo Identification and correctly answer a mathematical skill-testing question, sign a standard declaration and release form. This signature will act as confirmation of contest eligibility and compliance with the contest rules. AL and/or RED SHORES has no obligation to award any substitute prize and/or award any prize for any incorrect skill testing question.
