NOMINATION FEES: \$100 due Thursday, May 29th, 2025, by 3:00 p.m.

Payable by cash, cheque or credit card (no debit) to Red Shores Race Office.

Conditions:

1. All events and race conditions will be conducted under the rules and regulations of the Atlantic Provinces Harness Racing Commission, Standardbred Canada and Red Shores.
2. Declarations close at the time and date posted on the weekly condition sheet. Those declaring horses into this event are responsible for eligibility.
3. Competing horses must be 100% owned by PEI residents at time of nomination, declaration, and for the duration of the event. **RESIDENT:** A resident of PEI is a person whose primary residence is on PEI.
4. The race will be at a distance of 1 mile unless otherwise stated.
5. All starting positions shall be drawn electronically using the electronic draw system provided by Standardbred Canada
6. Purse distribution:
 - a. 5 or more starters: 50 — 25 — 12 — 8 — 5%;
 - b. 4 starters: 50 — 25 — 15 — 10%;
 - c. 3 starters: 60 — 30 — 10%;
 - d. 2 starters: 65 — 35%;
 - e. 1 starter: 100%.
7. All nominating fees will be added to the purse. Should conditions beyond the control of Red Shores prevent the racing of this event, Red Shores reserves the right to declare off the event and distribute the nomination fees to the current eligibles, or to transfer the event to another date, or to another track, or to do both.
8. Red Shores reserves the right to make any changes to conditions and schedule they deem necessary.
9. All owners, trainers, drivers must be members in good standing with the APHRC and Standardbred Canada.
10. **All horses must meet the qualifying standards of Red Shores.**
11. Should there be horses with common ownership; Red Shores reserves the right to uncouple horses for pari-mutuel purposes as per APHRC Rule 206.
12. A declaration for this event is an agreement to all the above terms and conditions.
13. Red Shores accepts no responsibility or liability for any accident, loss, or damage, which may occur on their property as a result of these, or any races.
