**PROMOTION ELIGIBILITY**

1. This promotion is sponsored by Red Shores Racetrack & Casino and is open to any Red Shores patron who is nineteen (19) years of age or older, with the following exceptions: Current or former employees of Atlantic Lottery Corporation (including Red Shores Racetrack & Casino), or of any promotional agency involved with this promotion, and any Immediate Family members of any of these employees, which employees and their Immediate Family members shall be ineligible to participate in and/or claim any reimbursable prize for this contest.
  - 1.1. “Immediate Family” means the spouse, sibling, parent and/or child of an employee referred to above who resides with that employee.
2. In the event a participant does not meet the eligibility requirements, then Red Shores has no obligation to award any prize to that selected contestant.
3. Winners must present valid photo identification acceptable to Red Shores and sign a declaration and release before receiving the prize.

**HOW TO ENTER**

4. Must enter Red Shores Charlottetown to participate.
5. **Earning Ballots** – ballots can be earned from July 3<sup>rd</sup> – August 9<sup>th</sup>, 2025, through the following methods:
  - 5.1. **Racing** – Spend \$20 or more on Live Racing at Red Shores Charlottetown to earn one (1) ballot. Must be a single transaction. Limit of one ballot per customer.
  - 5.2. **Casino** – Spend \$20 while playing the slot machines with a Rewards Club card at Red Shores Charlottetown to earn one ballot per day. Limit of one ballot per player, per day can be obtained through this method.
  - 5.3. **Dining** – Spend \$20 or more at O’Brien’s Social Bar & Kitchen, Red’s, or Top of the Park to earn one ballot. Must be a single transaction. Limit of one ballot per customer.
  - 5.4. **No Purchase Necessary** – If a guest does not wish to make a purchase to enter this promotion, they must complete a reasonable, hand-drawn facsimile of the RED SHORES logo on a piece of paper given to them by a Red Shores employee. **One entry per person, per promotion can be obtained through this method.**
6. **How to Enter Ballots** – Players must write their first name, last name, and a contact phone number on the ballot(s) provided at Red Shores Charlottetown and place them into the assigned ballot drum located in the Main Lobby.

## DRAWS AND PRIZE DETAILS

7. **Weekly Draws** – There will be one (1) weekly prize draw every Friday evening at 6:00pm for secondary prizing. Weekly draws begin on July 11<sup>th</sup> and take place until August 15<sup>th</sup> (6 draws total). Weekly draws will take place at 6:00pm or soon thereafter. Weekly prize winners will be returned to the ballot drum for the Grand Prize Draw.
  - 7.1. **Weekly Prizing:** The weekly prize package includes: Red Shores 20<sup>th</sup> Anniversary Merchandise, a 20% off coupon for O’Brien’s Social Bar & Kitchen, a \$20 Racing Voucher, and \$20 Free Play.

  - 8.2. **Number of Draws:** One (1)
